Publications will be available to NGA Show attendees from **Sunday, February 23 – Wednesday, February 26** To reserve space, complete the form and return it with the publication title to Corinne Routhier at crouthier@nationalgrocers.org by Friday, **February 7, 2020**. Space must be reserved for all publications and shipped to the Hargrove Warehouse.

- Publications can only be distributed at the publication bin or at your booth. Publications distributed elsewhere risk expulsion from The NGA Show.
- A **\$250** per publication material handling charge, which includes labor costs and maintenance of bins, will be the responsibility of the publication company.
- Publications that are polybagged will not be displayed.
- Publications cannot be delivered to the San Diego Convention Center.
- If you are exhibiting at The NGA Show, please differentiate which boxes are for the Publication Bins and which are for your booth by adding your booth number and removing mention of the Publication Bins to your booth shipment.
